REGULAR COUNCIL MEETING:

The Rainsville City Council met in regular session on November 17th, 2014, at 5:30 pm at the Agri Center with the following members present: Mayor Pro-Tem Rodger Lingerfelt. Councilmembers: Joey Graham, David Holt, Melissa Ledbetter and Brandon Freeman. City Attorney: Dara Patterson.
Absent: Mayor Nick Jones.

Mayor Pro Tem Lingerfelt called the meeting to order and called the roll.

A motion was made by Graham and seconded by Freeman to dispense with the reading of the minutes for the November 3, 2014, regular council meeting, the November 3, 2014 Public Hearing and the November 12, 2014 Special Called Council Meeting and approved them as presented by the clerk.
Motion carried unanimously.

Item #1. A motion was made by Ledbetter and seconded by Freeman to authorize the city attorney to remove a sewer lien from the Y.A. Harrison property. Motion carried with all in favor.

Item #2. A motion was made by Graham and seconded by Ledbetter to approve the following three street light request, two located on Highway 35 and one on Marshall Road. Motion carried with all in favor.

Item#3. A motion was made by Graham and seconded by Ledbetter to allow the street department to use the side cutter on the Industrial Development Board property. Motion carried with all in favor.

Item #4. A motion was made by Graham and seconded by Ledbetter to purchase a table for a \$1000.00 for the Children's Advocacy Center banquet. Motion carried with all in favor.

Item #5. A motion was made by Ledbetter and seconded by Graham to allow the Library to spend up to \$1000.00 to purchase Spanish materials from RJ Discount Books. This will be paid out of a grant the library received. Motion carried with all in favor.

Item #6. A motion was made by Ledbetter and seconded by Freeman to extent the following members of the TBEC Board terms: Michael Garrett to 11-30-15 and Joe Flaherty to 11-30-15. Motion carried with all in favor.

Item #7. A motion was made by Freeman and seconded by Ledbetter to give all city employees a onetime pay raise on check date November 21, 2014. Motion carried with all in favor.

A motion was made by Ledbetter and seconded by Holt to pay the monthly bills as presented by the city treasurer. Motion carried unanimously.

A motion was made by Graham and seconded by Holt to adjourn at 5:40 pm. Motion carried with all in favor.
