**Item #1.** A motion was made by Freeman and seconded by Rosson **TO PASS AND ADOPT RESOLUTION 10-02-2017 (A) TO PAYOFF STATE REVOLVING FUND WARRANT SERIES 1998 DECEMBER 15, 2017. Motion carried with all in favor.**

**Item #2.** A motion was made by Stiefel and seconded by Byrum **TO PASS AND ADOPT RESOLUTION 10-02-2017 (B) AUTHORIZING THE HIRING OF KIM ERWIN WITH MORTON & ASSOCIATES FOR THE SEWER PUMP REPLACEMENT PROJECT AT RTI. Motion carried with all in favor.**

**Item #3.** A motion was made by Taheri Stiefel and seconded by Byrum **TO PASS AND ADOPT RESOLUTION 10-02-2017 (C) AUTHORIZING THE HIRING OF JAMES PAYTON WITH LADD ENVIRONMENTAL FOR THE SEWER PUMP REPLACEMENT PROJECT AT RTI. Motion carried with all in favor.**

**Item #11.** A motion was made by Rosson and seconded by Freeman to reappoint Joel Moncus to the Industrial Development Board to serve a one-year term. **Motion carried with all in favor.**

**Item #12.** A motion was made by Rosson and seconded by Taheri to reappoint Melissa Ledbetter to the Tom Bevill Center Board to serve a one-year term. **Motion carried with all in favor.**
