The Rainsville City Council met in regular session on April 6, 2015, at 5:30 p.m. at the Rainsville Agri-Business Center with the following members present: Mayor—Nick Jones. Council Members—Joey Graham, David Holt, Melissa Ledbetter, Brandon Freeman and Rodger Lingerfelt.

Mayor Jones called the meeting to order and called the roll.

A motion was made by Freeman and seconded by Graham to approve the minutes as presented.

Item # 1. A motion was made by Freeman and seconded by Ledbetter to accept the recommendation from Ladd Environmental to accept the bid for improvements at the WWTP— Motion carried with all in favor.

Item # 2. A motion was made by Lingerfelt and seconded by Graham to hire Robert Thompson; the architect to over-see the remodeling of The Weekly Post Building for a fee of \$ 15,200.00— Motion carried with all in favor.

Item # 4. A motion was made by Freeman and seconded by Ledbetter to have 100 Farmer's Market T-Shirts made to sell/give away at a cost of \$ 7.92 each—Motion carried with all in favor.

Item # 5. A motion was made by Ledbetter and seconded by Lingerfelt to have the floors at TBEC cleaned and re-coated by Monarch Carpet at a cost of \$ 2950.00—Motion carried with all in favor.

Item # 6. A motion was made by Ledbetter and seconded by Lingerfelt to post the City Judge's vacancy on 4-7-15 by 4:00 p.m. on the city's website, league website, and publish in the newspaper with reference to SEE WEBSITES for description and pay scale—closing date is 14 days out per judge—Motion carried with all in favor.
