**WORKSHOP:**

**REGULAR COUNCIL MEETING:**

The Rainsville City Council met in regular session on January 7, 2013, at 6:00 pm at the Rainsville Fire Hall Conference Room with the following members present: Mayor: Nick Jones.  
Councilmembers: Rodger Lingerfelt, Brandon Freeman, Joey Graham, David Holt and Melissa Ledbetter.

Mayor Jones called the meeting to order and called the roll.

A motion was made by Graham and seconded by Freeman to dispense with the reading of the minutes of the December 17, 2012, regular council meeting and approve them as presented by the clerk.  
Motion carried with all in favor.

**Item #1.** Mayor Jones made an recommendation to repeal **Ordinance #9-17-12 AN ORDINANCE MAKING THE VIOLATION OF A STATE HANDGUN AND FIREARM LAW A VIOLATION OF A MUNICIPAL ORDINANCE; TO PROTECT THE PUBLIC HEALTH BY ENFORCING ALABAMA STATUE: 13A-11-59 REGARDING CONDUCT AT THE CITY COUNCIL MEETINGS; AND PROVIDING FOR AN EFFECTIVE DATE.** After a discussion, a motion was made by Ledbetter and seconded by Graham to accept this recommendation as presented. Motion carried with all in favor.

**Item #2. Resolution #1-07-13A APPOINTMENT OF SUCCESSOR MEMBERS OF THE RAINSVILLE BEAUTIFICATION AND MEMORIAL COMMITTEE** was presented. After a discussion, a motion was made by Freeman and seconded by Graham to pass and adopt this Resolution as presented. Motion carried with all in favor.



**Item #5. Resolution #01-07-13 A RESOLUTATION DECLARING PERSONAL PROPERTY SURPLUS AND ORDERING DISPOITION OF SAME** was presented. After a discussion, a motion was made by Ledbetter and seconded by Graham to pass and adopt this Resolution as presented. Motion carried with all in favor.

A motion was made by Holt and seconded by Ledbetter to pay the monthly bills as presented. Motion carried with all in favor.
