The Rainsville City Council met in regular session on April 1, 2013, at 6:00 pm at the Rainsville Fire Hall with the following members present: Mayor Nick Jones. Councilmembers: Rodger Lingerfelt, Brandon Freeman, Joey Graham and Melissa Ledbetter. Absent: David Holt.

Mayor Jones called the meeting to order and called the roll.

A motion was made by Graham and seconded by Freeman to dispense with the reading of the regular council meeting minutes of March 18, 2013 and accept them as presented by the City Clerk. Motion carried with all in favor.

Item #1. Mayor Jones presented **Resolution No. 04-01-13**, and after a discussion, a motion was made by Graham and seconded by Freeman to pass and adopt this Resolution as presented. Motion carried with all in favor.

Item #2. A motion was made by Graham and seconded by Ledbetter to reschedule the May 20th 2013, regular council meeting to May 23th, 2013. Motion carried with all in favor.

Item #3. A motion was made by Ledbetter and seconded by Graham to transfer Wesley Loveless from full time firefighter to part time firefighter. Motion carried with all in favor.

Item #4. A motion was made by Ledbetter and seconded by Lingerfelt to transfer Cody Kenamer from part time firefighter to full time firefighter. Motion carried with all in favor.

Item #5. A motion was made by Ledbetter and seconded by Freeman to empower Fire Chief Ridgeway to purchase a lawn mower and weed eater for the fire department at a cost of \$758.85. Motion carried with all in favor.

Item #6. A motion was made by Freeman and seconded by Ledbetter to place a 3-way Stop sign at Fortner Road and Chavies Road. Motion carried with all in favor.

Item #7. A motion was made by Freeman and seconded by Lingerfelt to advertise for bids for a truck and ten roll dumpsters. Motion carried with all in favor.


Item #8. A motion was made by Freeman and seconded by Ledbetter to accept Chris Bowman's resignation from the Planning Commission Board. (Zoning). Motion carried with all in favor.

Item #9. A motion was made by Freeman and seconded by Ledbetter to install two outgoing phone lines for the DeKalb Annex. Voting yea: Jones, Ledbetter, Freeman. Abstained: Graham and Lingerfelt. Motion carried.


