The Rainsville City Council met in Regular Session on July 17, 2017 at the Rainsville Municipal Annex with the following members present: Mayor: Rodger Lingerfelt. Council Members—Marshall Stiefel, Bejan Taheri, Rickey Byrum, Brandon Freeman, Derek Rosson.

Mayor Lingerfelt called the meeting to order and called the roll.

Item #1. A motion was made by Taheri and seconded by Freeman to empower the Mayor to sign the yearly renewal contract with RDS. **Motion carried with all in favor.**

Item #2. A motion was made by Freeman and seconded by Rosson to authorize the payment of \$4,000.00 to ADEM for the fine associated with the unauthorized burn site. **Motion carried with all in favor.**

Item #3. A motion was made by Byrum and seconded by Taheri to authorize the purchase of a sign indicating the location of the Park/Pool/Veteran's Memorial for an approximate sum of \$1200-1500. **Motion carried with all in favor.**

Item #4. A motion was made by Byrum and seconded by Freeman to authorize the purchase of a tile replacement on 3rd Ave. for a sum ranging from \$700-1000. **Motion carried with all in favor.**

Item #5. A motion was made by Freeman and seconded by Taheri to authorize a sponsorship of \$500 to Meth Mountain Interrupted. **Motion carried with all in favor.**

Item #6. A motion was made by Freeman and seconded by Taheri to purchase lights at the pee wee football field for an approximate sum of \$14,000. **Motion carried with all in favor.**

Item #7. A motion was made by Rosson and seconded by Byrum to authorize the purchase of LED lights for the helicopter pad at the Fire Dept. The total is \$4640.00 with Sand Mountain Electric paying \$2320.00 of the cost. **Motion carried with all in favor.**

Item #8. A motion was made by Rosson and seconded by Byrum to purchase caps to place on top of the Veteran's Memorial at the City Park. Rosson later retracted the motion after discussion was brought up regarding the City accepting the Memorial as City property.

A motion was made by Taheri and seconded by Byrum to pay the monthly bills. **Motion carried with all in favor.**

A motion was made by Taheri and seconded by Stiefel to adjourn the meeting at 5:11 p.m. **Motion carried with all in favor.**
