## Regular Council Meeting Monday 5:00 p.m.

The Rainsville City Council met in Regular Session on July 3, 2017 at the Rainsville Municipal Annex with the following members present: Mayor: Rodger Lingerfelt. Council Members—Marshall Stiefel, Bejan Taheri, Rickey Byrum, Brandon Freeman, Derek Rosson.

**Mayor Lingerfelt called the meeting to order and called the roll.**

**Item #1.** A motion was made by Freeman and seconded by Byrum to authorize the hiring of Jerry D & Jack Hartline Excavating at the Waste Water Treatment Plant to assist in the clean-up at the burn site. **Motion carried with all in favor.**

**Item #2.** A motion was made by Freeman and seconded by Byrum **TO PASS AND ADOPT RESOLUTION 07-03-2017 (A) TO AUTHORIZE THE PAY-OFF OF THE STATE REVOLVING FUND WARRANT WITH A CALL DATE OF AUGUST 15, 2017 IN THE AMOUNT OF \$25,000.00. Motion carried with all in favor.**

**Item #3.** A motion was made by Byrum and seconded by Rosson to replace a sewer pump at Max Pack for a sum of \$1800.00. **Motion carried with all in favor.**

**Item #4.** A motion was made by Taheri and seconded by Rosson to authorize the purchase of an air conditioner for the break room at the Waste Water Treatment Plan for a sum not to exceed \$500.00. **Motion carried with all in favor.**

**Item #5.** A motion was made by Taheri and seconded by Freeman to authorize the hiring of TSP Glass to install door closures on the doors at the Library for a sum of \$1087.10. **Motion carried with all in favor.**

**Item #6.** A motion was made by Taheri and seconded by Rosson **TO PASS AND ADOPT RESOLUTION 07-03-2017 (B) TO SURPLUS 4 DESKS AND 6 DESK CHAIRS AT THE POLICE DEPARTMENT. Motion carried with all in favor.**

**Item #7.** A motion was made by Taheri and seconded by Byrum to accept Josh Hunter's resignation from the Police Department. **Motion carried with all in favor.**

**Item #8.** A motion was made by Taheri and seconded by Byrum to hire Chris Kirby in the Police Department at a rate of \$ 13.83 per hour with a start date of 07-04-2017. **Motion carried with all in favor.**

**Item #9.** A motion was made by Byrum and seconded by Freeman to replace a 36in. tile on George Wallace—toward Parker—with a 48in. tile for a sum of \$4,000.00. **Motion carried with all in favor.**

A motion was made by Rosson and seconded by Taheri to pay the monthly bills. **Motion carried with all in favor.**

A motion was made by Stiefel and seconded by Taheri to adjourn the meeting at 5:10 p.m. **Motion carried with all in favor.**
